Assemblies and the Municipal Councils; Judges, Prosecutors and any other member of the Judicial Power of any hierarchy, jurisdiction or court).

- b. Any political party, official, employee or person acting for or on behalf of a political party or candidate for public office (such as candidates for elected office, members of any political party and officials with administrative functions employed by political parties).*
- c. Any officer, agent or person acting for or on behalf of a foreign state and/or a public international organization (such as the United Nations, the Organization of American States, the European Commission, the European Court of Justice; the World Bank or the International Monetary Fund) or any of its agencies, departments or entities, or a company controlled or owned by them.*
- d. Any personnel hired by the agencies, entities or companies mentioned in the preceding paragraphs and/or advisors to any of the officers or employees defined.*
